 - ii. **P23/V1862/HH & P23/V1863/LB – Vale Cottage, High Street.** Repairs and improvements to interior and exterior of listed cottage including works to repair internal partition wall, installation of air source heat pump, replace uninsulated concrete and timber floor with breathable flooring and underfloor heating system, repair internal wall coverings, repair boundary wall, repair and replace porch roof covering, replace front door. **Granted**
 - iii. **P23/V1739/HH and P23/V1740/LB – Lilac Cottage, Woolstone Road.** Two storey rear extension to create larger kitchen to ground floor, and master bedroom with balcony to first floor. Awaiting determination.
